Weather is generally fine and we always hope for the finest warm sunny days. Often the weather on the coast can be brighter than inland and many of the bays anchorages offer shelter. The boat can cope with bad weather conditions and has full cockpit camper covers to keep dry should the weather change. We try to be optimistic but sensible, therefore cancellations due to the weather are unusual but can be made for safety and enjoyment reasons at our discretion. We do keep watch on the forecasts and if MJM Marine or the skipper cancel due to weather conditions we will endeavour to offer an alternative date or refund.

Terms and Conditions

SIGNED: DATE:

- 1. The Boat is offered for Charter subject to acceptance by MJM Marine (the Owner) to the Client (the Charterer).
- 2. To reserve the boat for charter, the Client should complete the Booking Form and return it to the address provided, together with the payment of the reservation deposit of 33% per booking. Following receipt of the Booking Form and reservation deposit MJM Marine will send a confirmation invoice. This is the formal acceptance of the booking and no refunds are available.
- 3. The full charter fee is payable on the day of the scheduled Charter.
- 4. In the event of a cancellation by the Client the reservation deposit will not be refunded.
- 5. A full day charter shall commence at 10.00am 5.30pm; half day charter 9.30am 1.30pm or 2.00pm 6.00pm. Evening charters are available at 6.00pm to 10.00pm. Other times may be considered depending on booked commitments.
- 6. The maximum number of Clients/Guests must not exceed 8. However, with advance notice larger groups may be accommodated with the use of a second boat.
- 7. The Client agrees to be a considerate guest and to respect the boat and other water users. The Client also agrees not to act in any way which would cause disturbance to those neighbouring boats and the client should take steps to prevent other guests from acting in a disturbing and anti social manner.
- 8. However, with advance notice larger groups may be accommodated with the use of a second boat.
- 9. Under no circumstance shall the owner's liability to the Client exceed the amount paid to the Owner for the boat charter.
- 10. Under no circumstances shall the Owner be liable for any loss damage or injury, which is the result of adverse weather conditions, riots, war, strikes or other matters beyond the control of the owner.
- 11. Should the Owner decides to cancel the charter due to safety or weather conditions (the decision of the Owner is final), 85% of the charter fee will be refunded or an alternative date will be provided. The Owner will not be liable for reimbursement of any other fees/costs incurred by the charterer.
- 12. Your comfort and safety is important to us and we respectfully advise that the skipper's decision is final.
